



The charts show the amount of annual giving by percentage of persons issued a charitable tax receipt.

e.g. Assumption: 26% of persons give less than \$100 per year.

An analysis of trends in giving shows:

- More than half of receipted donors in each parish donate less than \$500 per year (i.e. less than \$10 per week)
- 2. Assumption:
 - a. 10% of donors 48% of total receipted donations.
 - b. 56% of donors contribute 12% of total receipted donations.
- 3. Resurrection:
 - a. 8.75% of donors contribute 40% of total receipted donations.
 - b. 56% of donors contribute 11% of total receipted donations.

In 2019 there was an adjustment of salaries:

- A full-time accountant was employed for the first three months while the parish accounts were reviewed and brought up to date in consultation with the Archdiocese.
- A long-time employee retired and unpaid benefits were paid out.
- A parish business manager was hired part-time as the parish priest split his time between teaching
 duties at Newman College and Judicial Vicar of the Archdiocese and of the Interdiocesan Tribunal of
 Edmonton.

In 2020 one full-time employee and 1 part-time employee were put on temporary lay-off (due to COVID 19). One part-time employee was permanently laid off due to re-organization of office processes.


Pastor's Notes on the Financial Condition of the Parishes


- The financial health of a parish can be quickly seen by comparing Ordinary Sunday
 Collections to Ordinary Expenses; Sunday collections are the main source of revenue for
 parish life, and so, for a healthy financial parish, Ordinary Sunday Collections should meet all
 Ordinary Expenses.
- Other sources of revenues (e.g. interest income, cell tower rental, rental of parish property to third parties) should not be used to meet ordinary expenses, but should rather provide a fund that grows to assist with eventual large capital expenditures (e.g. replacement of roof, windows and heating).

Financial Health of each parish at a glance

- At the end of 2019 and in the first months of 2020, special donations were received in both parishes to help offset the expected announced deficit in both parishes.
- Assumption Parish: Once the pandemic affected our parish activities, we also received
 permission to draw out the interest on monies invested on behalf of Assumption Parish from
 the sale of the former St. James Parish; in addition Assumption received rental income in
 2020 from Gianna House (rectory rental) and the Vital Grandin Chaplaincy, who also
 contributed to offset expenses such as snow removal. One of the largest ordinary expenses at
 Assumption is heating costs, and we are currently investigating long-term solutions to help
 reduce these costs.
- A combination of continued generous financial contributions from parishioners despite the
 pandemic, and a significant reduction in expenses due to curtailed activities, allowed
 Assumption's Ordinary Sunday Collections to meet its Ordinary Expenses in 2020.
- Resurrection Parish: Similarly, Resurrection in 2020 was able to meet Ordinary Expenses
 from Ordinary Sunday Collections thanks to the continued generosity of its parishioners and a
 significant paring back of expenses due to curtailed activities arising from the pandemic.
- Going forward, we will continue to be vigilant in ensuring the financial health and viability of both parishes. Thank you to all for your support during these challenging times!







Note: The attendance data from 2019 are reproduced here since attendance during 2020 was restricted due to the COVID-19 pandemic.

Churches were entirely closed from mid-March until the beginning of June 2020, and then re-opened at a very restricted capacity depending on the physical size and layout of the building; further restrictions were imposed by December 2020, permitting a maximum of 15% of fire code capacity. For practical purposes, this meant that Assumption Church could hold a maximum of 78 persons and Resurrection a maximum of 74 persons, assuming those in attendance could also maintain a distance of two metres between households. The wearing of masks was mandatory by the end of the year.
