

The charts show the amount of annual giving by percentage of persons issued a charitable tax receipt.


e.g. Assumption: 21% of persons give less than \$100 per year.

An analysis of trends in giving shows:

- 1. Across both parishes 38% of donors give less than \$100 per year.
- 2. Across both parishes, 65% of donors give less than \$500 per year.

In 2021 there was an adjustment of salaries: One part-time employee was hired (beginning of October 2021). Recall that in 2020, due to the effects of the COVID-19 pandemic, there were both temporary and permanent staff layoffs and curtailed expenses also arising from reduced parish activities.

◆Reporting across the years and between the parishes was not always consistent; despite inconsistencies, the data presented here is intended only as a guide to see what trends emerge over a historical patern.


Pastor's Notes on the Financial Condition of the Parishes


- The financial health of a parish can be quickly seen by comparing Ordinary Sunday
 Collections to Ordinary Expenses; Sunday collections are the main source of revenue for
 parish life, and so, for a healthy financial parish, Ordinary Sunday Collections should meet all
 Ordinary Expenses.
- Other sources of revenues (e.g. interest income, cell tower rental, rental of parish property to third parties) should not be used to meet ordinary expenses, but should rather provide a fund that grows to assist with eventual large capital expenditures (e.g. replacement of roof, windows and heating).

Financial Health of each parish at a glance

- Assumption Parish: Assumption continued to receive rental income in 2021 from Gianna House (rectory rental), the Vital Grandin Chaplaincy, and the Rogers cell tower. A snow removal contract was completed upon retirement of the long-term parishioner who had provided this (thank you Jim Birn!). One of the largest ordinary expenses at Assumption continues to be heating costs.
 - Unfortunately, Ordinary Sunday collections did not meet ordinary expenses in 2021, with a shortfall of about \$45,000. Rental income was used to cover a portion of expenses.
- Resurrection Parish: Resurrection continued to receive rental income in 2021 from the Rogers cell tower.
 - Resurrection in 2021 was able to meet Ordinary Expenses from Ordinary Sunday Collections, with a small surplus of collections over revenues of \$10,000.
- Going forward, we will continue to be vigilant in ensuring the financial health and viability of both parishes. Thank you to all for your support during these challenging times!







Note: The attendance data from 2020 (prior to the pandemic) are reproduced here since attendance during 2021 was restricted due to the COVID-19 pandemic.

While precise restrictions varied over the course of the year, practically speaking this meant that Assumption Church could hold approximately 78 persons and Resurrection approximately 74 persons, assuming those in attendance could also maintain a distance of two metres between households. The wearing of masks was mandatory throughout the year.
